IMPORTANT NOTICE NYPIUA ADOPTS NEW LOSS COST MULTIPLIERS

This important notice is being issued to inform you that the New York State Insurance Department has approved new dwelling loss cost multipliers for use by NYPIUA.

The New Dwelling Loss Cost Multipliers are as follows:

	Loss Cost Multipliers
Fire:	2.071
Allied Lines:	2.033

The Commercial Loss Cost Multipliers remain unchanged:

	Loss Cost Multipliers
Fire:	1.846
Allied Lines:	1.812

Remember to apply the "Adjustment Factors" below as a final step when calculating the rate.

The dwelling "Adjustment Factors" are:

	Adjustment Factors
Owner occupied Dwellings:	1.05
Non-Owner Occupied Dwellings:	1.30
Household Furnishings:	1.10

The new Dwelling Loss Cost Multipliers will go into effect February 1, 2009 for new business and April 1, 2009 for renewals.
