NEW E-DELIVERY OF INSURANCE

This summer, NYPIUA is joining the national effort to help preserve and protect our environment. This effort takes many forms from recycling plastic, metal, and paper to using less of them. Producers already have the option of electronic delivery of policy information. Now, because of our goal to become environmentally friendly, we will be extending this service to our insureds, starting early next year.

Effective immediately, insureds can enroll in our E-Delivery program. For now we are asking policyholders to click on the "Electronic Delivery E-mail Address" icon on our website, **www.nypiua.com** to provide us with an e-mail address. By doing so we will be able to e-mail important policy information as well as policy alerts and activity notifications, when the program begins.

This program has many pluses:

1. Protects the environment.
2. Stops wasteful use of natural resources.
3. Eliminates reliance on postal delivery and potentially slow or lost mail.
4. Provides real-time electronic access to all policy information.
5. Removes worry about insurance documents being lost. If an E-document is misplaced, the policyholder can go to our website **www.nypiua.com** to print another. All E-forms and policy information will be available on our website and permanently stored on our system at a secured location.
